

INTRODUCTION

The full qualification (NQF 3) prepares the learner to work as a Home Based Personal Care Worker (HBC), while the part qualification (NQF 2) allows the learner to work as a Home Based Personal Care Assistant. The full qualification covers more theory and allows the learner to take on more responsibility, while the part-qualification focusses predominantly on practical aspects of care. Both categories require professional supervision and support.

PURPOSE OF THE TRAINING

A Home-Based Carer will be able to provide supervised care and support to patients and household members in the home, in order to promote, restore and maintain a person's comfort, function, spiritual wellbeing and physical health including care towards a dignified death. The work of a Home-Based Carer focusses on therapeutic work (to make better), rehabilitative work (to restore to health), long-term maintenance (to care for over a long time) and palliative care (for those with life-limiting conditions). All these tasks require time and commitment and imply a longer-term relationship with clients/patients.

ADMISSION CRITERIA

Learners enrolling to do the full qualification (NQF3) must have the following:

- Grade 12 schooling with English or any other grade with Foundational Learning Competence ([FLC](#)).

Learners enrolling to do the part qualification (NQF2) must have the following:

- A qualification at Abet Level 4 or Grade 9 Schooling

MAXIMUM NO OF PARTICIPANTS

Maximum of 30 students per group.

COURSE DESIGN

The two qualifications require knowledge modules, practical skills modules and workplace experience.

Full qualification – 5 Knowledge Modules, 6 Practical Modules, 8 Workplace Experience Modules
(1350 notational hours over 1 year)

Part qualification - 1 Knowledge Module, 3 Practical Skills Modules, 4 Workplace Experience Modules
(700 notational hours over 6 months)

Learning Outcomes

1. Provide holistic care and support to patient and household members
2. Communicate effectively with patients and household members
3. Operate effectively and efficiently within a multi-disciplinary team context
4. Recognise when to refer, and who to refer to whom, and why
5. Complete a generic guideline report/template on patient care
